We invited Mads & Monopolet to the Great Wall of China, Danced the night away with Tim Christensen at our Charity Spring Gala and invited the Danish Community to a session with celebrity psychologist and debateur Svend Brinkmann. We are delighted that we have been able to provide high quality events and we hope to see you all for many more great occasions in 2020.

Through 2019 we have also started a deeper cooperation with the EU SME Centre to further benefit the SME segment of the chamber members as well as supporting workgroups efforts under the EU commission and the EUCCC to ensure that the voice of the Danish chamber and all our members is heard where it counts.
