Summary:

Mathias is the General Manager for Europe for TuSimple AI (NASDAQ:TSP). TuSimple is leading the drive for fully-autonomous driving solutions for the logistic industry. TuSimple has the first and only commercial ready “driver out” level (SAE) trucks, capable of self-driving from depot-depot and already have operations doing so every day for its customers. TuSimple trucks have driven millions of kilometers of road testing during the last 24 months and have performed over 7 full “Driver Out” missions since 22 December 2021. The company is driven by a mission to increase safety, decrease transportation costs and reduce carbon emissions. In Europe TuSimple has a partnership with TRATON Group and its brands Scania and MAN Trucks. Mathias is a director of TuSimple Sweden AB.

Scope of responsibility: Strategy, partnerships, HR, Finance and Legal Admin for TuSimple Europe.

Prior to TuSimple, Mathias was Country Manager for Danske Bank China - the largest bank in Denmark and second largest in the Nordic region. As Chief Representative, Mathias’ responsibilities comprised managing the bank’s relationships in China across financial institutions and the regulators, as well as the bank’s clients in the region. Mathias was also responsible for leading and executing Danske Bank’s strategy in Greater China.

Prior to Danske Bank, Mathias was a Senior Investment Manager for IFU (Investment Fund for Developing Countries), the Danish sovereign investment fund, based in Shanghai working out of the organization’s Greater China Regional Office. Mathias was responsible for IFU’s investments in Greater China and Mongolia.

Before joining IFU, Mathias was the Chief Representative of CSR Capital, of which he was one of the founding members. The fund was focused on SRI investments in China, Africa, India, and Denmark and backed by the founder of Bestseller Group, a family-owned clothing company based in Denmark with 100,000 employees worldwide.

Mathias graduated from the University of London, School of Oriental and African Studies (SOAS) with a bachelor’s degree in Politics and has previously studied at Peking University, Copenhagen Business School, Copenhagen University, and AVT Business School in Copenhagen for various certificates and executive training.

Over his career, Mathias has sat on the boards of 16 companies, four of which were Sino-Foreign Joint-Ventures where he also acted as Vice Chairman. He is currently the Chairman of the Danish Chamber of Commerce China (DCCC) (North China), Executive Vice-Chairman of the Beijing Foreign Investor’s Club, member of the executive board of VL100, a group established for Danish executives in North China, and on the executive committee of the board of trustees at the International School of Beijing (China’s oldest and most acclaimed International School).
