Chris is a strong advocate for sustainable design and has worked with companies like NIO to create their first Net Zero Energy NIO House at their manufacturing base in Hefei and led the design of the world's largest Waste to Energy Power Plant in Shenzhen, known as the 'Energy Ring' that utilizes both Danish design, and Danish technology to become one of the first LEED Gold industrial buildings in China.

Chris holds honorary academic roles as a Professor of Architecture at The Scott Sutherland School of Architecture in Aberdeen, UK, and a Distinguished Professor of Design at Zhengzhou Institute of Finance and Economics in China, exemplifying his understanding of the strong link between design and business. Chris continues to work across all regions of China, and globally, and is a strong advocate for promoting Denmark within China, not only as a country, but as a 'platform' and a 'mindset' for collaboration, sustainability and world class design.
